

The 74<sup>th</sup> Meeting of the HOD convened on Sunday, June 12, 2022 and Tuesday, June 14, 2022 in Phoenix, Arizona. In June, the HOD collectively considered 22 policy recommendations, 19 of which were amended or edited. Policy recommendations included various topics such as Cultural Competency, Human Use of Veterinary Pharmaceuticals, Autoverification of Medication Orders, and Access to Reproductive Health Services. 

#### On Being an Entrepreneur- A Different Pharmacy Path

As a pharmacy student in Boston, I worked at a local hospital as a pharmacy technician preparing doses of intravenous medications. My job was to batch large intravenous (IV) bags using medications that were packaged in glass ampoules. I had to stand on my feet for long hours breaking glass ampoules and filtering them according to the "Standards of Good Practice," that I was taught. It involves multiple needles, needle exchanges and multiple steps. I thought it was time consuming and cumbersome and was convinced that there had to be a better way. After graduation, I worked as a retail manager for CVS for 17 years. Back then, retail paid much more than hospital pharmacy but my passion was always hospital pharmacy. I left CVS to work as a clinical hospital pharmacist for the next 17 years in various patient units of the hospital including, ICU, ER, Oncology, NICU, and medical surgical areas. Throughout my career, the filtering problem kept bothering me. I noticed my technicians struggling, and the process was not always performed properly in emergency situations.

I decided to come up with a simple solution to a complicated problem. I consulted a patent attorney and after receiving my first patent I founded CarrTech in 2012. Next, I searched for a medical device manufacturing company to build my prototype. I was introduced to a company Durham North Carolina, whose engineers and I brainstormed to develop the first prototype. I had my second patent prepared at this time, and it was completed in late 2017.

Until 2018 I bootstrapped my way through two patents and an alpha prototype. "Bootstrapping" is when you use your own money to build traction. Having a novel idea for a new medical device isn't enough!

To build a viable company and products I needed to raise funds, network, attend educational accelerators, develop strategic partners and learn the art of public speaking. In 2018 I began to raise money. My first two investors were fellow pharmacists that believed in CarrTech's mission. I began to network, as well as conduct customer discovery questionnaire interviews with my healthcare friends. One of my "secret sauces" or advantage over other entrepreneurs is that I know a lot of people in healthcare. Building a company requires education. I attended accelerators, incubators, and I-Corp programs. I continued to learn about the business world and develop tools to use such as the lean business model canvas, executive summaries, pitch decks, and business plans. I learned what a value proposition was, who my customers were, my strategic partners and it all made sense. I began to formalize my company, hired a corporate attorney, established CarrTech formally as an LLC and received my first investors via convertible note called "Friends and Family"

I took a complicated process of filtering and made it simple by designing an all-in-one device called "FROG", (Filter Removal of Glass). Basically, I just relocated the filter from the Luer Lock end to the tip and placed the filter cover over a hypodermic needle. After the ampoule is broken, the fluid is drawn up and filtered and the outer cover can then be removed revealing an inner hypodermic needle. Primary research confirmed that healthcare providers prefer FROG over the current system, it take half the time and 100 % of respondents felt that FROG would decrease the chance for needle-stick injuries. It was so simple, I thought a big needle company, (BNC is the acronym I use), would love this idea and buy me out, end of story. However, I not only need to sell them on FROG, but also myself. Public speaking becomes essential. Currently, the hardest thing for me to date, is public speaking. I sought out help to improve my confidence and speaking ability. I took a leap of faith in February of 2019. I left the security of a full-time job to work full time on CarrTech. After completing the IPHA program, the EDGE program at the Frederick Innovation Technology Center Inc (FITCI), I won a small pitch competition sponsored by Frederick County. It was my first big win and my team was with me that night to celebrate. The week before COVID hit, I had an opportunity to pitch in front of 500 + people at the Cary School of Business at the Baltimore Waterfront for a Connect Entrepreneur event. I had pitched in Frederick, MD for a small group of investors, that same afternoon. COVID hit and I thought it was the end of CarrTech. Because of COVID, I was able to watch my son graduate University and pitch at Salisbury University's "Shore Hatchery Competition" a half an hour later. I won 5th place and \$10 K. It was a very good day. I decided to rent space at FITCI since there was a village of supporters and mentors that continue to guide and support me, and I had an actual business address. Because of those last two pitch events prior to COVID, I was accepted into the, Maryland Technology Development Corporation (TEDCO) Builder Fund and eventually acquired a lead investor. TEDCO taught me leadership and management skills, a positive culture, and invested in CarrTech. TEDCO continues to provide advisors and assistance in many ways. Maryland Tech Council, and Maryland Commerce have supported CarrTech in many ways a well. I hired a CFO, CEO, and now an R&D specialist and in December of 2021, I began R&D to prepare for an FDA application which brings me to present day. It has taken a long time to design the right filter with the right pull force, receive outside testing validation, and conduct human factor studies in the U.S. and EU. On August 23rd, CarrTech, (now CarrTech Corp), met with the FDA with a pre-submission document. It was an exciting moment. They are looking forward to CarrTech's submission. There is still a lot of work to do but we anticipate submitting our first of many 510 (k) Class II medical devices in Q1 of 2023.

I'm not at the finish line but I am getting closer to it every day. It takes a village of supporters and I have a prodigious village and an amazing team supporting CarrTech's mission of making medication preparation better and making a difference. It has been an incredible journey and I would not trade it for anything in the world. If I can save just one life, then my journey has been worth it. I hope this inspires others to follow their heart, believe in their "Why," and pursue their dreams.

## Prevention and Control of Seasonal Flu: ACIP Recommendations 2022-23 Influenza Season

As many of you may already be aware, the US has experienced atypical timing and duration of influenza activity in the recent 2021-22 season<sup>1</sup> and as we are getting ready for the uncertainties of the upcoming influenza season, I wanted to bring attention to the annual publication of the Prevention and Control of Seasonal Influenza with Vaccines: Recommendations of the Advisory Committee on Immunization Practices — United States, 2022–23 Influenza Season | MMWR (cdc.gov).<sup>2</sup>

Below are Key Highlights from the Updated ACIP Influenza Vaccination Recommendations.

Routine annual influenza vaccination is recommended for all persons aged ≥6 months who do not have
contraindications. For each recipient, a licensed and age-appropriate vaccine should be used. With the exception of
vaccination for adults aged ≥65 years, ACIP makes no preferential recommendation for a specific vaccine when more
than one licensed, recommended, and age-appropriate vaccine is available.<sup>2</sup>

NEW: ACIP recommends that adults aged ≥65 years <u>preferentially receive</u> any one of the following higher dose (HD-IIV, RIV) or adjuvanted influenza vaccines (aIIV):<sup>2</sup>

- Quadrivalent high-dose inactivated influenza vaccine (HD-IIV4; Fluzone High-Dose, Sanofi)
  - $\circ$  Contains 60  $\mu$ g HA antigen per virus compared to 15  $\mu$ g for SD-IIVs
- Quadrivalent recombinant influenza vaccine (RIV4; Flublok, Sanofi)
  - $\circ$  Contains 45  $\mu$ g HA antigen per virus compared to 15  $\mu$ g for SD-IIVs
- Quadrivalent adjuvanted inactivated influenza vaccine (alIV4; Fluad, Segirus)
  - $\circ$  Contains 15  $\mu$ g of HA per virus, same as SD-IIVs, but contains adjuvant MF59.

If none of these three vaccines is available at an opportunity for vaccine administration, then any other age-appropriate influenza vaccine should be administered.² Literature concerning the efficacy, effectiveness, and safety of HD-IIV, RIV, and allV versus nonadjuvanted SD-IIVs and of each of these three vaccines with one another in this population was evaluated using systematic review, GRADE, and the ACIP Evidence to Recommendations Framework. On this basis, the recommendations for influenza vaccination of persons aged ≥65 years were modified. A description of the systematic review and GRADE is available at <a href="https://www.cdc.gov/vaccines/acip/recs/grade/influenza-older-adults.html">https://www.cdc.gov/vaccines/acip/recs/grade/influenza-older-adults.html</a> and an abbreviated summary is in the MMWR publication (linked at the top of this email).² HD-IIV, RIV, and alIV have shown relative benefit compared with SD-IIVs in certain studies, with the most evidence available for HD-IIV3.²

#### 2. Timing of Influenza Vaccination<sup>2</sup>:

- Optimally, vaccination should occur before onset of influenza activity in the community. Because timing of the
  onset, peak, and decline of influenza activity varies, the ideal time to start vaccinating cannot be predicted each
  season.
- Influenza vaccines might be available as early as July or August; however, vaccination during these months is not recommended for most groups because of the possible waning of immunity over the course of the influenza season.
- For most adults (particularly adults aged ≥65 years), vaccination should ideally be offered during September or
  October. However, vaccination should continue after October and throughout the influenza season as long as
  influenza viruses are circulating and unexpired vaccine is available.
- Please refer to the full text MMWR publication (linked at the top of this email) for considerations for pregnant persons and children.

#### 3. Co-Administration of Influenza Vaccines with COVID-19 Vaccines<sup>2</sup>:

During the 2022–23 influenza season, SARS-CoV-2 is expected to continue to circulate in the United States, and COVID-19 vaccinations are expected to continue.

- Current guidance for the administration of COVID-19 vaccines indicates that these vaccines can be
  administered with influenza vaccines; providers should consult "Coadministration of COVID-19 vaccines with


#### **Introduction:**

World Pharmacists Day, now in its 12th year was celebrated and commemorated this year on September 25<sup>th</sup>. The theme for this year's World Pharmacists Day, "Pharmacy united in action for a healthier world" was intended to showcase pharmacy profession's positive impact on health around the world and to further strengthen solidarity among members of the profession.

The World Pharmacists Day campaign is led by the International Pharmaceutical Federation (FIP) every year and provides an opportunity to promote the pharmacy profession (1). As the global body representing pharmacy, pharmaceutical sciences and pharmaceutical education, the FIP supports global health and promotes the advancement of pharmacy practice, pharmaceutical sciences, and education.

The FIP invites colleagues from all sectors of the pharmacy profession to take part in the campaign and show the world how pharmacists are united for health- overcoming conflict, different politics and cultures, and economic disparity. Citing the FIP president's thoughts on World Pharmacists Day: "The United Nations Sustainable Development Goal number 3 sets out a number of health targets, including for non-communicable diseases (such as cardiovascular disease, cancer, diabetes, chronic respiratory disease, and mental health) and communicable diseases (for example, HIV, tuberculosis, and neglected tropical diseases). We have seen improvements in many of these areas and our profession should be proud of and make known its contributions. However, the COVID-19 pandemic has hindered progress and it is imperative that we rally to build back better" (1).

## **Background on the International Pharmaceutical Federation**(FIP)

The International Pharmaceutical Federation FIP) was founded in 1912 and is headquartered in The Hague, Netherlands. It is the global federation of national organizations of pharmacists and pharmaceutical scientists and is a non-governmental organization in official relations with the World Health Organization (WHO). With over 146 member organizations, FIP represents over four million pharmacists, pharmaceutical scientists, pharmacy educators and more than 170 academic institutions globally.

For pharmacists, FIP's vision means a dedication to advancing patient-focused, medicine-centered healthcare practices for all. FIP has expanded its focus from changes in pharmacy and the emergence of pharmacy practice as a cornerstone of the profession which led FIP to become globally visible to advocate pharmacists' role in the provision of healthcare while still maintaining a focus in the pharmaceutical sciences.

The FIP has four areas of membership focus with each being interrelated based on members' practice interests and disciplines. The areas include pharmacy practitioners, pharmaceutical scientists, pharmacy educators and young pharmacists/new graduates (Young Pharmacists Group). A member joining FIP can choose any of the following FIP Sections (under pharmacy practitioners) based on practice or specialty interests, through which they can become active, take leadership roles, and contribute to FIP educational and program initiatives, viz. Community Pharmacy, Academic Pharmacy, Industrial Pharmacy, Hospital Pharmacy, Social and Administrative Pharmacy, Military and Emergency Pharmacy, Health and Medicines Information, and Clinical Biology. FIP members interested to connect with young pharmacists and pharmaceutical scientists as well as seek new networks in professional innovation, friendship and support, can join FIP's Young Pharmacists Group (YPG). FIP has several Special Interest Groups (SIG) on specific pharmaceutical disciplines.

The FIP organizes the World Congress of Pharmacy and Pharmaceutical Sciences each year during the fall in a host country. Since the Covid-19 pandemic in 2020, the FIP Congress venue planned in Seville, Spain, was held as a virtual meeting until 2022 when FIP held its 80<sup>th</sup> World Congress in-person in Seville, Spain this year. Attending the FIP Congress gives an international experience to interact with the FIP membership that has evolved to become the most extensive global pharmacy and pharmaceutical sciences network. The FIP Congress program includes an array of educational, social and networking opportunities with formal opening and closing ceremonies, showcase exhibits, and ACPE-approved continuing education sessions.

Annual FIP Congresses are not FIP's only activity. Each year it holds a number of conferences usually in conjunction with other organizations which are smaller and more specialized than the annual Congress and some are done in collaboration with WHO on a regional basis. The FIP is also a partner with the International Pharmaceutical Students Federation (IPSF) which is the leading advocacy organization for pharmacy and pharmaceutical science students and holds its own conferences.

FIP shares an extensive number of resources and guidelines in its website intended for pharmacists on a number of pharmacy practice, disease management and pharmaceutical science standards. FIP provides comments on guidance documents for WHO on pharmaceutical science and practice standards. On the Covid-19 pandemic, FIP issued a call to action to support pharmacists that highlight measures to ensure continuity of pharmaceutical care to people worldwide so that pharmacists can play an even greater part in the fight against Covid-19.


