In 2017, WMSHP was able to deliver quality **educational programs** through our partnerships with the University of Maryland and other Pharmacy Organizations. In total, **15 CE** Pharmacy continuing education units were made available to members which included: the Spring all day **6 CE** Event (Breaking Ground I: Enhancing Clinical Knowledge in Pharmacotherapeutics), the Fall all day **6 CE** Event (Breaking Ground II: Enhancing Clinical Knowledge in Pharmacotherapeutics), and a half day **3 CE** Event in collaboration with the CPA/MedNovations. In 2017, WMSHP has taken on the task of revising our current Constitution and Bylaws to better reflect best practices and to align our chapter more closely to standards set by ASHP. Key revisions revolve mainly around the roles and responsibilities of "Student" Members and "Technician" Members: how they are elected, qualifications, etc. In addition, our overall Constitution and Bylaws have been thoroughly vetted under rigorous legal review by ASHP Attorneys for overall appropriateness and intent. The proposed revisions will be posted for comment in early January for a prerequisite time period as stipulated in our current Constitution and Bylaws. Final Note: a Qualtrics Survey to tally votes will be sent out in the coming weeks for all members to confirm (details to follow).


