# Networking- Perspectives from an industry pharmacist professional

Prior to my current role in Medical Affairs in the pharmaceutical industry as a Senior Regional Medical Manager for Supernus Pharmaceuticals, I had served in community retail pharmacy practice for two years after graduating from the University of Maryland School of Pharmacy, while becoming a pharmacy manager in the process. Shortly after my career in community pharmacy practice, I transitioned to a private practice setting where I worked as a clinical pharmacist. These positions helped me develop a strong business acumen and build relationships with other healthcare providers in the community. Networking advice that I strongly recommend to new pharmacy graduates and pharmacists is to develop a growth mindset while networking. Additionally, it is vital to develop your knowledge of the specific role you desire within your network. Modern networking is also vital, and for example, LinkedIn is a strong tool to communicate with professionals currently in the role you are seeking. Set up a time to speak with them so that you may be more knowledgeable of the role during screening or phone interviews. Developing your network on a consistent basis is a great way to increase your chances of securing a position, because they will reach out to you when positions become available. Finally, know that there are several opportunities right now that need your unique skill sets and experience. Having a mentor that can guide you with a specific plan will dramatically improve your chances and ultimately lead to you securing your ideal role as a pharmacist practitioner and professional.

Dr. Cummins' presentation explained the basics of the virus, mechanisms of actions associated with the therapeutic targets, and also included the implications and considerations beyond the science. The options of having a virtual chat box and an audiovisual component facilitated a healthy discussion. For the July 8<sup>th</sup> CE symposium session, Han Feng, PharmD, Supervisory Pharmacist for Medication Safety at the NIH Clinical Center, presented on "A Spectrum of Risk: Analyzing the Use of Color in Medication Safety." As pharmacists, we all work toward ensuring safety in our diverse areas of pharmacy practice and the topic of how color is used and perceived in differentiating medication dosage forms and packaging in patient care on an operational and clinical level, spurred an excellent discussion and highlighted the work that remains in the area of medication use and safety. We are also looking forward to July 30th, when Ferdaus Hassan, PhD, Medical Science Liaison (DC/MD/VA) of Sanofi Pasteur, US Medical Affairs, will be presenting a non-CE pre-symposium session on "Influenza: Cardiovascular Risks and Considerations during the COVID-19 Pandemic."

## WMSHP Pharmacy Teaching Certificate Program: Success Demonstrated During COVID-19 with Virtual Resident Research Presentations

There are 15 fellowship and ASHP-accredited pharmacy residency programs in the Washington, DC area. For the last 16 years, residents, fellows, residency directors, residency preceptors and medical colleagues from the pharmaceutical industry have demonstrated teamwork and participated in an all-day seminar program, offered four to six times per residency year. Literature has shown that opportunities for residents to develop teaching skills vary among programs across the United States. Our team concurred with this gap and developed curricula for a Teaching Certificate for pharmacy residents and fellows participating in residency and fellowship programs in the Washington, DC area. We launched the WMSHP Teaching Certificate Program in the 2012-2013 pharmacy residency year.

The Washington Metropolitan Society of Health System Pharmacists (WMSHP) Pharmacy Teaching Certificate program has the mission to prepare pharmacy residents and fellows for competitive career placement, while enhancing residents'/fellows' application of educational principles and practical skills for effective didactic and clinical teaching. It is a collaborative effort coordinated by WMSHP and led by pharmacist leaders in the Washington, DC metropolitan area which was initiated in 2012, and has been executed each year since that time.

As we have all adapted to our ever-changing environments since the onset of COVID-19, the same has held true with the WMSHP Pharmacy Teaching Certificate Program. The leadership team for this group met virtually towards the end of March 2020 to determine the next steps given this environment. We were alerted to the fact that the Eastern States Conference for Pharmacy Residents and Preceptors had been cancelled. One of the requirements for successful completion of the WMSHP Pharmacy Teaching Certificate includes a presentation of the resident's research project. The team developed a plan of action to conduct Resident Research Project presentations virtually in lieu of doing so at the Eastern States Conference. Over the course of one month, the team was able to conduct virtual resident research project presentations designed to simulate the live Eastern States Conference. This included the resident research project presentations, evaluation by an audience of peers/faculty, and follow-up by designated faculty to provide feedback (based on audience survey information). The team developed a Survey Monkey tool that was identical to the Eastern States Conference evaluation for audience members to use to provide feedback on each presentation. In addition, the team identified and designated a faculty member to serve as both Facilitator and Lead Evaluator for each session. After completion of all resident research project presentations, the team received positive feedback that this adaptation was very successful.

Amid the COVID-19 situation in 2020, the leadership team achieved in successfully distributing the Teaching Certificates to all residents this year who successfully met all requirements. Each individual site Residency Program Director was responsible for affirming their pharmacy resident's completion of requirements and the subsequent presentation of Resident Teaching Certificates. Success was demonstrated in terms of the team's adaptation of the environment given the COVID-19 situation. A total of 19 residents were awarded Teaching Certificates as a result of completion of the program requirements. The feedback to date has been very positive and it is clear that the WMSHP Pharmacy Teaching Certificate Program has filled a need locally for teaching skills, education, professional development, and leadership for pharmacy residents and fellows, especially during this unexpected time affecting all of the pharmacy profession and particularly in this virtual environment.


